<b>Annual Percentage Rate (APR) for Purchases &amp; Balance Transfers</b>	<b>2.99%, 3.99%, 4.99%, 5.99%, 7.99%, or 8.99%</b> Introductory APR for the first 6 months from account opening, depending on your credit history. After that, your Standard APR will be <b>8.9%, 9.9%, 10.9%, 12.9%, 14.9%, or 15.9%</b> depending on your credit history. This APR will vary with the market based on the Prime Rate.
<b>APR for Cash Advances</b>	<b>10.9%, 11.9%, 12.9%, 14.9%, or 16.9%</b> depending on your credit history. This APR will vary with the market based on the Prime Rate.
